Summary of Resource Opportunity: USGBC will provide free training for 10 communities on PEER, a new third-party certification program and road map for sustainable power system performance. PEER provides an independent evaluation of overall power system performance, opening the door to identifying new opportunities for improvement and developing a plan for PEER certification.

For community teams that have completed an introductory PEER webinar, USGBC will provide training on how to complete the PEER Assessment. The PEER Assessment is an assessment of overall project sustainability while building the case for investment. The assessment utilizes the PEER framework to inform and build upon the existing sustainable energy plans, quantify the value produced to date, and identify new opportunities for improvement. The webinar will provide tools and technical training for communities to assess their power grids. The assessment is a simple first step and can be used to enter into PEER Participation and eventually apply for certification, or as a stand-alone tool for driving action, innovation, and investment.
